Call to Order at 5:00 pm

Formica/Estate/Essex ARIP Engineer Update Call with Jay Wheaton from Mead and Hunt. Working on updating the plans. They are hoping to get wetlands plans completed and submitted next week. Also keeping the railroad updated with plans and schedules to get permits when needed. Should have 90% plans in the next couple of weeks.
